The Essex County Council (Various Roads (North of Lower Road) Hullbridge, and Rawreth) (20mph Zone) Order 202*

Notice is hereby given that the Essex County Council proposes to make the above Order under section 84(1)(a) and (2), and Part III of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended)

Effect of the order: To Implement: a '20mph Zone'.

Road	Description
Admiral Crescent, Hullbridge	From its junction with Lakeland Avenue, for its entire length. Including any turning heads, and Private Drives.
Bartons Avenue, Hullbridge	From its junction with Buttermere Gardens, for its entire length, to its junction with Lowlands Road, approximately 173 metres.
Brandy Avenue, Hullbridge	From its junction with Bartons Avenue, for its entire length, to its junction with Malyons Lane, approximately 148 metres.
Buttermere Gardens, Hullbridge	From its junction with the roundabout at Lower Road, for its entire length, to its northern junction with Admiral Crescent, approximately 759 metres. Including any turning heads.
Coniston Crescent, Hullbridge	From its junction with Minke Mews, for its entire length. Including any turning heads, and Private Drives.
Eveleigh Gardens, Hullbridge	From its junction with Brandy Avenue, for its entire length, approximately 71 metres. Including any turning heads.
Freeman Road, Hullbridge	From its junction with Buttermere Gardens, for its entire length, to its junction with Brandy Avenue, approximately 122 metres.
Hawes Close, Hullbridge	From its junction with Lowlands Road, for its entire length, approximately 59 metres. Including any turning heads, and Private Drives.
Hilton Crescent, Rawreth	From its junction with Buttermere Gardens, for its entire length, approximately 428 metres. Including any turning heads, and Private Drives.
Lakeland Avenue, Hullbridge	From its junction with Minke Mews, for its entire length, approximately 99 metres. Including any turning heads, and Private Drives.
Lowlands Road, Hullbridge	From its junction with Buttermere Gardens, for its entire length, approximately 489 metres. Including any turning heads, and Private Drives.
Malyons Lane, Hullbridge	From its junction with Elm Grove, west for approximately 192 metres, to its junction with Buttermere Gardens.
Minke Mews, Hullbridge	From its junction with Admiral Crescent, for its entire length. Including any turning heads, and Private Drives.
Raven Way, Hullbridge	From its junction with Lakeland Avenue, for its entire length, to its junctions with Minke Mews, and Admiral



	Crescent, approximately 205 metres. Including any turning heads, and Private Drives.
Smugglers Close, Hullbridge	From its junction with Buttermere Gardens, for its entire length, to its junction with Brandy Avenue, approximately 116 metres.
Ullswater Drive, Hullbridge	From its junction with Lowlands Road, for its entire length, approximately 53 metres. Including any turning heads, and Private Drives.
