### 142/03/23 Planning Applications

**142.1**/03/23 Members *considered* the below applications:

**23/00001/FUL – 305-307 Ferry Road, Hullbridge.** Single storey extension to existing outbuilding (workshop/office) and use as annex - *No Objection, we don't agree with Place Services submitted assessment.* 

23/00173/FUL – 5 Pooles Lane, Hullbridge – Two storey rear extension. No Objection, however, if approved, we recommend a strong traffic management plan is put in place on this narrow road for the loading/unloading and wait times of building supplies and materials, as this will have a detrimental impact for the access and the flow of traffic here as this is the only road in and out to feeding road Kingsman Farm Road and for residents of Pooles Lane. Pooles Lane is a narrow road at this particular point.

**23/00185/FUL – 80 Keswick Avenue, Hullbridge** – Proposed Single storey rear and part side extension . *No objection, however we note the plans would make the boundary under the 1m boundary rule.* 

23/00195/FUL – 82 Keswick Avenue, Hullbridge – Proposed ground floor side extension and new porch. *No Objection* 

### 143/03/23 Street Lighting
