## 2. Approval of Minutes

## 5. Allotment Plot Holder Changes / Inspection and Competition

- 5.1 The Committee noted that only one plot was vacant (plot 59b) this was very overgrown and flooded in the winter months.
  - RESOLVED Plot to be offered to holders of 59A if they do not want then the Committee will get the area strimmed and the area will left as grass open space. Plot will be withdrawn.
- 5.2 Following the plot inspection letters will be sent to plots 29 and 45b (including repair of fruit cage), these will be checked in a couple of weeks to see if sufficient work has been carried out. Plot 73 to be sent letters regarding overgrown grass. All Sheds and greenhouses in a good condition.
- 5.3 Best Allotment Competition to take place on 6<sup>th</sup> July 2016. Judge Heather Brickwood Husband will be the judge for 2016.
  - ACTION Clerk to do and put up posters (short list 7<sup>th</sup> June)

#### 6. Allotment

- 6.1 ECC Highways ditch culvert clearance, confirmed that they have fixed the problem but water is still sitting in ditch and not flowing.
  - ACTION Clerk to chase up ECC Highways to find out what work they actually did.
- 6.2 Footpath maintenance, a small area of plastic matting was installed and the Committee agreed that it has improved the conditions of the footpath especially during the winter months. Members agreed to make are recommendation to Full Council for all of the main footpath to be fitted with the matting approx. 60 metres, the working party will fit them.
  - RESOLVED Recommendation to Full Council for expenditure of £600 for the matting.
- 6.3 RESOLVED request for an additional trough near plot 39b was refused.
- 6.4 RESOLVED Water troughs maintenance work to be carried out at the end of the season / winter.
- 6.5 Trees near plot 80 our tree surgeon has carried out an inspection and confirmed that the trees are in good condition and not a danger to plot holders. There is some evidence of some dead wood but not a concern. One tree due to its lean is recommended to be coppiced at the end of the year when crops have finished and the plot holders belongings / shed contents can be moved for the work to be carried out.
