5. Approval of Minutes

7. Allotment Plot Holder Changes / Inspection and Competition

- 7.1 Plots 58a / 58b / 107 have been re- let. Plot 52a has been offered.
- 7.2 It was noted that in the short term due to personal circumstance plot 105 is being maintained by another plot holder.
- 7.3 Following the plot inspection letters were sent to plots 10 / 31a / 39a / 76a / 43a / 43b / 85 / 93a / 98b these will be checked in a couple of weeks to see if sufficient work has been carried out. Plot 66 a letter of termination has been sent and plot 85 has now relinquished their plot with immediate effect.
- 7.4 Best Allotment Competition is taking place on 2nd July Judge Heather Brickwood a poster has been put up on the Noticeboard and if any plot holder does not want to be considered for the Competition then they need to advise the Parish Clerk.

8. Allotment

- 8.1 Clerk is waiting for the Water Company to confirm if there is a leak at the stopcock near to Lower Road.

- 8.3 RESOLVED it was agreed that footpath maintenance especially in the first half of the site will be carried out by the working party. (Soil can be used from behind plot 95).

- 9.1 RESOLVED Members agreed that if plot 66 shed is not removed as the plot holder has had their contract terminated then it will be dealt with by the Committee / Working party.
- 9.2 RESOLVED Committee Members agreed for Plot 58a to move greenhouse to 45b.
- 9.3 RESOLVED- Members reviewed the current sizes and agreed the following sizes:

Shed = 6x4Greenhouse = 8x6Poly-tunnel = 8x6

Plot holders cannot have a greenhouse and a Poly-tunnel it must only be one or the other.

Plot holders must have confirmation of the location of the above by a Committee Member and especially in the top field as it is exposed the above must be sufficiently pegged to the ground.

10. Ditch

- 10.1 RESOLVED Members agreed that the ditch will be cleared by are concerned that even by doing this it will not resolve the problem of the water that sits on the road near the bus stop. This has been reported to Essex County Council Highways.
 - ACTION Clerk to get a quote for a day's hire of a small digger.
- 10.2 RESOLVED Members agreed the Working Party Weekends will be 27/28th June and 23/24th October between 10am noon. ACTION: Clerk to do poster.
 - It was raised when the fire is lit in November that the wind direction is considered before it is lit so neighbouring properties are not affected.
- 10.3 Members noted that the farmer has cleared the opposite ditch ACTION – Clerk to find out from ECC if the Culvert is blocked that crosses the road as the bus stop gets regularly flooded.
