#### 13. Approval of Minutes

- 13.1 Minutes of the meeting held on **17**<sup>th</sup> **April 2019** were approved and ratified previously by the Full Council. Chair John Delasalle signed the minutes.

## 16. Allotment Plot Holder Changes / Inspection/Competition

- 16.1 Committee Members noted the recent plot changes and numbers on our waiting list.
- 16.2 Committee Members agreed several plot holders will be sent initial letters and these plots will be re-inspected on 9<sup>th</sup> July 2019.

**ACTION:** Admin to send out letters and print out updated inspection reports/map for follow-up inspection and advise Ian Burrell once letters have been issued.

16.3 Committee Members noted the competition shortlist.

#### 17. Allotment site

17.1 Fence Panels leaning into the site. Committee Members could not confirm if the fence Panels were still leaning into the allotment site.

**ACTION:** Committee Members to assess if fence panels are still leaning into site and advise the Parish Office.

17.2 Members noted the number of vacant plots. It was proposed that Hullbridge Parish Council Maintenance staff strim vacant plots to control weeds blowing into neighbouring plots.

- 17.3 Water Tank Repairs Committee Members noted that the small water repairs had been fixed and that no reimbursement of supplies was necessary.
- 17.4 Committee Members confirmed that the rubbish issues by the bench have now been resolved and that the notice about rubbish on the bench is an effective deterrent.
- 17.5 Acrid Smoke concern Members noted the concern regarding acrid smoke from a neighbouring resident and are satisfied with the way the Parish Council have dealt with this issue.
- 17.6 Wild Meadow plot 59B. Committee Members agreed to convert plot 59B into a wild meadow provided that neighbouring plots have no objection. The Essex Wildlife Trust are going to suggest certain flowers that are not evasive. Committee Members agreed to call this plot "The Orchard plot".

**ACTION**: Admin to email neighbouring plots to ascertain if there are any objections.

- 17.7 A number of people on the waiting list have declined various plots each offered to them. Committee Members agreed that once they have declined five plots then they lose their place on the waiting list and will be put at the end.
- 17.8 Committee Members proposed to inspect the ditch/culvert area to ascertain if this needs to be dug down further so that rainfall flows away properly. It was proposed to look into the possibility of having a grill/drain put into the car park that leads into the ditch to remove some of the surface water from the car park.
